At the completion of the fellowship the 66B will synthesize CDC knowledge and processes into the Army paradigm to provide advanced application of Public Health and Preventive Medicine processes toward Force Health Protection in both the operational and garrison settings in support of DoD medical readiness and force sustainment. In order to successfully compete the Centers for Disease Control Fellowship the officer must present a capstone presentation at the annual Public Health Course which is normally held on the east coast, most recently at Ft. Dix, NJ (Joint Base McGuire-Dix-Lakehurst). Each year the dates fluctuate, but normally they are the first week in August. The approximate cost estimate for 2024 would be \$1,621 to fly from Atlanta, GA to Philadelphia, PA (closest to Ft. Dix) including per diem (\$610), flight (\$329), and rental car (\$281). As a matter of a capstone project and this presentation is to highlight the significant interagency coordination accomplishments, project milestones and strategic imperatives as current and future public health trends and threats in order to better prepare Army public health officials for future operational and strategic planning objectives.

The Joint Commission's accreditation and certifications are recognized nationwide as a symbol of quality in health care. The DHA now manages the contract with TJC and is tasked to oversee TJC compliance within MTFs.
