**SUBJECT: Announcement of Calendar Year (CY) 2023 U.S. Army Reserve (USAR) Lieutenant Colonel (LTC) Command Board (CMD BRD) Troop Program Unit (TPU) and Active Guard Reserve (AGR) Selections – June 2023 Slate**

**1. References:**

b. Office of Chief of Army Reserve (OCAR), DAAR-HR memorandum (Chief of Army Reserve Policy #21-02A: Amendment - United States Army Reserve (USAR) Colonel (COL) and Lieutenant Colonel (LTC) Command (CMD) Board Program), 4 November 2022.

c. Office of Chief of Army Reserve (OCAR), DAAR-HR memorandum (Chief of Army Reserve Policy #21-02: United States Army Reserve (USAR) Colonel (COL) and Lieutenant Colonel (LTC) Command (CMD) Board Program), 29 June 2021.

d. Army Regulation 140-10 (Army Reserve Assignments, Attachments, Details, and Transfers).

e. Army Regulation 135-18 (The Active Guard Reserve Program).

f. United States Army Reserve Command (USARC), AFRC-OP memorandum (USAR Brigade Battalion Pre-Command Course (BBPCC) Attendance Policy), 18 July 2022.

2. The Department of the Army (DA) Secretariat conducted the CY23 USAR LTC CMD BRD on 12 July – 4 August 2022 at Fort Knox, Kentucky. The Chief of Army Reserve (CAR) approved the board results on 14 December 2022. Enclosures 1 and 2 lists officers slated to fill LTC AGR and TPU commander positions, respectively.

3. Slated officers will assume command within the given month as annotated on the enclosed USAR LTC Command selection list. The USARC G-1 will remove officers who

do not assume command, as annotated, and do not have an approved exception. The requests for exception to this requirement must be fully justified and submitted to the USARC G-1 Command Board mailbox indicated in para 9.

a. AGR officers slated for command will submit a DA Form 4187, Personnel Action, either accepting, deferring, or declining the position within 14 days of the publication of this memorandum. Officers will submit their DA Form 4187 to their assignment officer at the U.S. Army Human Resources Command (HRC) and email a copy to the USARC G-1 Command Board mailbox in para 9. Officers who do not submit a DA Form 4187 as instructed will receive a declination with prejudice, and the USARC G-1 will remove them from the slate.

b. Major Subordinate Command (MSC) Commanders will coordinate with officers selected for TPU positions on whether they are accepting, deferring, or declining the position for which slated. Officers selected for TPU positions will submit a DA Form 4187 either accepting, deferring, or declining the position within 30 days of the publication of this memorandum. Officers will submit their DA 4187 to the gaining MSC Commander and email a copy to the USARC G-1 Command Board mailbox in para 9. Officers who do not submit a DA Form 4187 as instructed will receive a declination with prejudice and the USARC G-1 will remove them from slate. Gaining MSC Commanders will coordinate with USARC G-1 Command Board Team to re-slate positions when necessary.

c. Slating officials will remove from the slate officers who become flagged (suspension of favorable personnel action) for any reason prior to the projected change of command date and re-slate the position in accordance with current policy.

4. The standard tenure for command positions filled by this board is 24 months or as identified on the enclosures. When in the best interest of the Army Reserve, MSC Commanders have the option of processing up to 12 additional months of tenure for 24 month-tenure positions based on mission essential requirements in accordance with reference 1a. The total tenure will not exceed 36 months. The tenure period for an acting commander slated to fill the same commander position begins on the date the officer assumed acting commander status.

5. Pre-Command Course (PCC):

a. Attendance at the Battalion Brigade PCC (BBPCC) is mandatory in accordance with AR 350-1 (Army Training and Leader Development) for officers selected for battalion command. Officers who have attended the BBPCC previously as a BN

Commander are not required to attend. USAR officers selected for BN Command will attend the 2-day USAR BBPCC (school code: 921, course 921-2G-F157/521-F4) and the 12-day School of Command Preparation (SCP) BN PCC (school code: 701, course: 2G-F22/521-F1 (BN)(CP)) at Ft Leavenworth, KS. The timeframe to attend is not earlier than 6 months prior to but no later than 12 months after assumption of Command. Commands will not enroll a Soldier for a course date scheduled to report within a 14-calendar day window. There is also a PCC course prerequisite requirement: Completion of the Web-based Leader's Safety and Occupational Health Course (LSC) (2G-F107\_DL) must be done prior to an ATRRS reservation for PCC courses. b. The dates for the combined 2-day USAR BBPCC and the SCP PCC course are:

6 – 21 July 2023	10 – 25 August 2023	13 – 27 October 2023
5 – 19 January 2024	9 – 23 February 2024	15 – 29 March 2024

c. Phase I: USAR BN selected commanders must attend the USAR BBPCC and SCP BN PCC successively. The USAR and SCP courses are a total of 14 instructional days (15 w/travel). Unit Army Training Requirements and Resources System (ATRRS) operators will enroll personnel into course.

(1) Phase Ia: 2-day USAR specific course is conducted at Ft. Leavenworth, KS. The 83d Army Reserve Readiness Training Center (ARRTC) facilitates the course.

(2) Phase Ib: 12-day, branch immaterial course, is required of all BN Commanders (TPU and AGR). The SCP BN PCC is conducted at Ft Leavenworth, KS.

(3) There are additional requirements for selected individuals:

(a) Prior to assuming command, individuals assuming O5 garrison command, and those LTCs assuming command who have Special Court Martial Authority are required to complete a 4.5-day Senior Officer Legal Orientation Course (SOLO) (course number 5F-F1), held at the Judge Advocate General's Legal Center and School located in Charlottesville, VA.

(b) Command specific course (Operational, Initial Entry Training, Installation, etc.) conducted at Army proponent locations. Attendance is required for all AGR personnel.

TPU personnel may attend if seats and funding are available. Unit ATRRS operators will enroll personnel into the course.

(c) Branch specific course at the officer's branch school (maneuver enhancement brigades, Brigade special troops battalions, etc.). Attendance is required for all AGR officers. TPU officers may attend if seats and funding are available. Unit ATRRS operators will enroll personnel into the course.

d. Spouses are encouraged to attend the Army Reserve Family Program (ARFP) Senior Spouse Course and the Active Component Spouse Course held in conjunction with the Soldier's PCC.

(1) The ARFP Senior Spouse Training is a 2-day USAR specific course and takes place on Saturday and Sunday in conjunction with the USAR BBPCC. The training is resiliency-based education. The course includes a comprehensive overview of ARFP Quality of Life programs and services. Registration is in ATRRS. The course information is as follows: School Code -300; Course Number- USAR SR SPOUSE CRS BBPC. The unit training NCO will input an A1 application in ATRRS for the spouse to attend the course.

(2) The Active Component Spouse Course is a 5-day course held in conjunction with the Soldier's first week of the Phase Ib PCC. The Active Component 5-day course is scheduled via ATRRS under School Code 701 (2G- F162/521-F15 (CT)). The unit's ATRRS operator is responsible for enrolling spouses into the spouses' course.

(3) These courses have been approved by the Department of Defense, thus spouse travel to attend is at the government's expense. Funding is approved by the student's unit.

#### 6. Funding and Career Advisor Contact Information:

a. MSCs receive funding for TPU Soldiers' BBPCC attendance through their Fiscal Year Operating Budget. If a Soldier attends BBPCC prior to assuming command, and the gaining MSC is different from the losing MSC, course attendance will be funded by the losing unit's MSC. If the losing unit's MSC does not have sufficient funds for attendance, the losing unit's headquarters may submit a request through the losing MSC's G-38 to USARC G-37 Leader Development at [usarmy.usarc.usarc-hg.list.g37-leader-development-division@army.mil](mailto:usarmy.usarc.usarc-hg.list.g37-leader-development-division@army.mil) requesting additional funds. The request will be validated and then the USARC G-38 will push funding to the requesting (losing unit)

MSC to publish orders and fund travel for the Soldier. HRC is responsible for publishing orders and funding travel for AGR, IMA, and IRR Soldiers attending BBPCC.

b. The current TPU unit of assignment will publish orders. HRC publishes orders for IRR/IMA Soldiers. Officers will contact parent unit if order has not been received 30 days prior to school report date.

c. Career Advice.
